A Restorative Community would likely have...

Schools

- Full School conflict resolution education programs
- School discipline policies allow for restorative measures when addressing wrongs in preference to exclusionary practices
- School administrators and teachers have 25 hours of restorative practices and conflict resolution training

University/Colleges

- Conflict studies and training
- School policies allow for restorative measures when addressing wrongs within the university in preference to exclusionary practices
- Education and Social Sciences degrees include 40 hours of restorative practices and conflict resolution training

Community

- Community Conferencing Centers for Victim-Offender Dialogue Meetings and Community Conciliation Cases
- Community Response Teams for victims
- Support and Accountability Teams for offenders
- Community Policing
- Support programs for family of victims and offenders
- Child Advocacy Center
- Incentives for using alternative dispute resolution to address conflicts
- Child care programs leaders and staff receive 25 hours of restorative practices and conflict resolution training

Health Services

- Assurance of physical and mental health needs being provided
- Support counseling for individuals and their families
- Substance Abuse Treatment
- Impact statements available for determination of needs and responsibilities

Faith Organizations

- Coordinated and supported in taking on community service sentencing supervision, support groups, healing and reconciliation, community impact statements for courts, reforms
- Members included in VOM and Support and Accountability Conferences
- Asked to serve on Public Policy Planning and Review Boards

Courts

- Restorative Justice Coordinators who may also serve the court in the Community Conferencing Centers
- Restorative plans and diversion contracts affect sentencing decisions based on successful compliance prior to sentencing
- Victim Assistance and information about court proceedings as well as prepared impact statements for court determinations
- Separation and Child Custody Contracts with mediators
- Restorative Conferencing for offenders with mental health limitations

Policing

- Community Police coordinate with community leadership
- Specialist in Restorative Justice also provide training for the department
- Coordinators for Mental Health needs of offenders and victims
- School Resource Officers trained in VOM conferencing

Corrections and Re-Entry

- Access to substance abuse, trauma and mental health treatments
- Educational and job skills programs
- Opportunities to be responsible to family obligations and victim restitution agreements
- Open to VOM and Victim Advocacy Conferencing
- Coordinators for community release to Support and Accountability Programs in the communities where they will live and work.
- Programs for Women (improved)

Business and Employment

- Incentives for employers to hire individuals who are in restorative programs at fair labor wages
- Business Community's Cooperative with policing in processing theft and property damage to reduce time and cost of court procedures

Offenders

- Opportunities for ex-offenders to have full citizenship rights restored
- Family impact statements developed for sentencing and separation decisions.
- Legal services for correcting court records

Public Policy Reviews and Recommendations

- Commission to review current and past needs to redress justice restoratively and to evaluate current justice policy's impacts on the community (financial and human resources)
- Strategic Planning and report to city/county government
- Periodic reviews of community's needs and program assessment
- Plan and coordinate trainings and conferences
