



Data show mediation as highly effective in repairing relationships and boosting understanding across racial lines. The goal of mediation is to


restore the respect so teachers can teach and students can learn.




Three Years of Teacher-Student Mediation at Centennial High School in Champaign, IL:



What occurs in an ideal classroom:


- Students and teachers treat each other with sensitivity and civility.
- Students are valued as individuals and encouraged to participate without fear of put-downs from the teacher or other students.
- When conflicts arise, teachers and students effectively communicate and problem solve. (Danielson & McGreal, 2000)

When classrooms are less than ideal:

- Black males and students with disabilities are the most heavily impacted by discipline policies that remove them from the classroom (Klotz, 2014).
- Differences in how teachers discipline black and white students contribute to racial disparities and spur repeated student misbehavior among black students (Okonofua & Eberhardt, 2015).

Why mediate with teachers and students:

- Enhances student achievement
- Boosts mutual understanding
- Breaks negative cycles
- Promotes social-emotional learning
- Provides an individualized intervention
- Is efficient and free of charge
- Fosters understanding, trust, and empathy
- Benefits all members of a school community
